

## Funding

SFWIB receives over 70 million Federal dollars per fiscal year through WIA, Wagner-Peyser, TAA, SNAP (formerly FSET), TANF and the Refugee programs.



# Outcomes Last 3 Program Years

- Number of placements = 108,375
- Average cost per placement = \$1,756
- Training Outcomes:
  - Net Economic Benefit per placement = \$24,279
  - Average Wage = \$14.83
  - Placement Rate = 63%
  - ROI for every dollar invested in training = \$3.70

## **Consumer Report Card (continued)**

- The SFW Consumer Report Card is an on-line report and was developed to update ITA performance on a daily basis.
- The goal of the tool is to function as an "ITA Consumer Report Card," enabling the consumer (participant), as well as, the Career Advisor to check on the success of individual programs and to evaluate the economic benefit per placement by program.

## **Consumer Report Card (continued)**

#### **Economic Analysis**:

- The Consumer Report Card table indicates that for past three years the South Florida economy increased by \$48,048,568.
- For every dollar spent on training, SFWIB obtained a return of \$3.70.
- Nearly 83 percent of the WIA participants completed class room training.
- Of those completing training, 63 percent have obtained employment with an average wage of \$14.83.



## **Consumer Report Card (continued)**

#### **Economic Analysis**:

- Seventy-two percent of the participants were placed in an occupation they trained for.
- The net economic benefit per placement is \$24,279.



increase our businesses competitive advantage in a global economy.




