EAGLE FORD

- May be the largest oil and natural gas formations outside of Alaska in U.S. history.
- The first well drilled in 2008, and over the next four years, production has consistently exceeded year-over-year expectations.
 - From 2010 to 2011, natural gas production more than doubled (272 billion cubic feet), and
 - Oil production increased by more than six times (28 million barrels).
- Such growth translates to significant economic impact to the communities, such as Laredo, directly involved in production, as well as those in surrounding counties.



JOB GROWTH

- Texas job growth is expected to continue outpacing the national rate.
- The U.S. rate was 0.7 percent in 2010 and 1.2 percent in 2011, and predicted U.S. job growth will rise slightly to 1.3 percent in 2012.
- The surprise in 2011 was the loss of local and state government jobs
 - Fifteen percent of Texas jobs are tied to local and state governments. Budget cuts last year dropped the number of those jobs by 4.4 percent
 - We hope we have seen a stabilization of those jobs.





FY 2011- \$26,935,220


➤ More Hotel Occupancy Tax Revenue



There Are Challenges to Growth

Real Estate:

• 96.2% apartment occupancy rate in 2010 while great, results in higher rental rates.

Municipal Services:

- Increased growth results in increased demands on municipal services
 - 623 new water utilities accounts growth 2010 vs. 2011
- We are now selling "brown water" to be used in the FRAC practice we are seeing funds and have reduced need for new treatment plant.

- Laredo is projected to be #1 in the nation in percentage of job gains over the next 10 years
- Workforce is projected to swell to 145,860 total by 2022.
