**Beyond Recycling – Reducing Packaging (& Everything Else)** @ the Source For many of us, the ideal approach to waste management is to not create it in the first place – that is, to prevent a product or commodity from ending up in the waste stream. Practically speaking, this can mean eliminating the use of certain materials and/or products, or re-purposing/re-using products that might otherwise end up in the waste stream. In this session we'll hear about creative ways that municipalities can reduce the amount of waste in their stream, through effective source reduction and diversion strategies.

### 10:45am – 12:00pm Disaster Planning in the Age of the Superstorm

During a weather event, existing collection and disposal systems will almost always be disrupted; more than that, extra waste will be created by the event itself. If this cascade of waste isn't dealt with quickly, serious health risks can develop, which will further endanger a community already devasted by the emergency. In this session, solid waste chiefs from Texas, Florida, and other regions will look back at key hurricane events in 2018 (arguably the most destructive hurricane season in memory) and share lessons learned about over managing solid waste in the age of the superstorm, in the immediate aftermath and in the weeks, months and years that follow.

 (Re) Building Recycling Markets in the Wake of National Sword

 Since China officially implemented National Sword in January of

Since China officially implemented National Sword in January of this year, the landscape of recycling has arguably been transformed. It's meant a profound contraction of what's long been the most significant market for American recyclables. Municipal solid waste (MSW) agencies, like the solid waste industry at large, are understandably concerned. But, experts say, the sky *isn't* falling. In this session we'll discuss the history and events that led up to National Sword, and critical changes MSW must make in its aftermath – including re-evaluating recycling metrics, working toward vital improvements in recycling quality, and developing new markets for recyclables, in the near and long term.

This panel will discuss how the State of Massachusetts tested contamination fighting strategies to build a grant program for communities all over the commonwealth to pay for and tackle this national issue. Also, El Paso, TX will discuss their citywide approach to minimize contamination with an ROI in mind, and The Recycling Partnership will weave the national contamination story together with updates on National Sword and how stakeholders are collaborating to improve quality.
