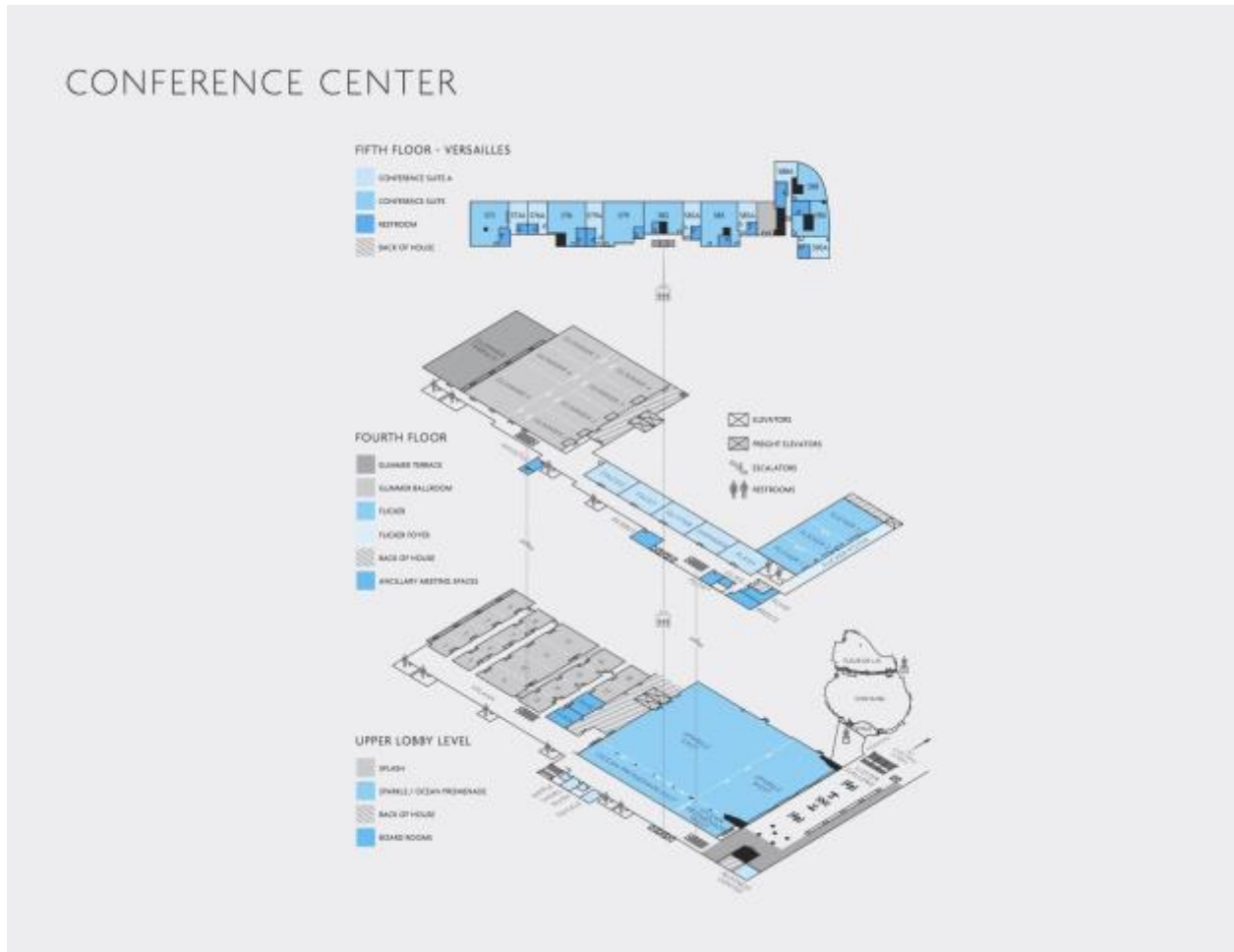

BUSINESS SESSION VOTING CREDENTIALS: Voting Credentials will be available for the Monday Business Session Vote at the Conference Registration Desk, located in the Luster Gallerie, Upper Lobby Level, Fontainebleau Hotel, beginning at 7:00 a.m. on Sunday, June 25.

It will be necessary for all Official Delegates who wish to vote to have these credentials in their possession. There is but one credential for each member city. If the Mayor of a member city is registered, the credential will be issued to him or her. If the Mayor is not registered and has not been in attendance at the Annual Conference, a registered official from his/her city must have been designated, in advance, in writing, to be the Official Delegate to receive the city's credentials.

If a registered Member Mayor anticipates that he/she will not be present at the Business Session, he/she may designate an alternate, who must be a registered official from his/her city, to pick up the city's voting credential and exercise the city's vote on Sunday morning. Such an alternate, however, cannot have the floor to speak to any issue under discussion.
