PAYT Forward: The Pay-As-You-Throw Model @ Work. In communities with pay-as-you-throw (PAYT) programs, residents are charged for the collection of municipal solid waste based specifically on the amount they throw away. This creates a direct economic incentive for residents to recycle more, and to generate less waste. There's an inherent fairness and equity to the PAYT model – not to mention an enhanced opportunity to create financial sustainability for municipal solid waste programs. # Fighting Contamination from All Sides: Ohio's New Approach

In 2018, the Ohio EPA approached The Recycling Partnership to develop a more inclusive, comprehensive model for addressing contamination. The Partnership & the Ohio EPA convened a group of stakeholders including MRFs, solid waste districts, and municipal leaders to identify needs and challenges; out of this dialogue a strategic pilot program was born. This session, moderated by The Recycling Partnership, will feature representatives from the Ohio EPA, a partnering MRF, and a grant-funded community. You'll learn the challenges and successes these stakeholders faced in working toward an effective, replicable model to fight contamination in communities across Ohio, and discuss how what has worked in Ohio might be adapted to fit your community.

Markets and Recycling Technologies I: Today. Recent market disruptions have left municipal managers of recyclables with a suite of challenges and questions: Should we cut certain materials from our curbside programs? Are there domestic markets for our materials? What options are available to optimize our system and program? In this session, we will address these questions and more by highlighting opportunities and successes occurring across the system spanning new technologies to measure and improve yields at the MRF, trends in domestic processing markets, and commitments by manufacturers that are creating new "market pulls".

Markets and Recycling Technologies II: Tomorrow. With increased attention to the effects that materials mismanagement can have on recycling programs, the environment, and beyond, there are now unprecedented levels of activity in the research and commercial development space for next-generation solutions to waste-related challenges. Here we'll sift through the noise to highlight the state of the science on a new class of chemical recycling technologies being developed to transform the management and value of discarded plastics. We'll focus on examples of promising technologies, level-set with respect to their commercial development, and discuss how municipalities might take advantage of the potential opportunities coming down the road.

Waste Conversion Technology as a Market Strategy. While National Sword and similar restrictions put in place by other countries have constricted the markets for U.S. recyclables, one positive development has been the renewed emphasis on quality (versus quantity). As communities think about ways to maximize value and reduce costs – if not generate income – some industry experts say it's time to re-evaluate waste conversion solutions. In this session you'll hear from representatives of RePower South, which has begun operation at two facilities this year—just outside of Charleston and in Montgomery, Alabama – utilizing mechanical systems to screen in-bound waste for undesirable contaminants, recover valuable materials and size the balance of the waste material to create a valuable fuel product for use as a coal substitute. Both the financial and environmental benefits will be explored, as well as challenges to implementing these types of programs and the opportunities they represent.
