1:00pm – 2:15pm	Extended Producer Responsibility: Legislation, Trends, & Opportunities
	Beginning at the beginning, starting at the source: this session will provide an overview of first-generation Extended Producer Responsibility (EPR) programs, and of brand new EPR laws for packaging in Maine, Oregon, Colorado, and California. Discussion will focus on how EPR policy implementation is evolving and how these programs are modernizing, and on how the differences between these laws present opportunities to explore different approaches and draw lessons for future policy development.

2:15pm – 3:30pm	EPA, PFAS, CERCLA, and Other Worrisome Acronyms
	The Environmental Protection Agency (EPA) has delayed, until February 2024, publication of its final rule designating certain per- and polyfluoroalkyl substances (PFAS) as hazardous substances under the Comprehensive Environmental Response, Compensation, and Liability Act, or CERCLA. This delay represents a temporary reprieve for local governments, who as passive receivers of PFAS might nevertheless end up bearing the brunt of the financial burden for remediation. In this session, panelists will provide a history and timeline of EPA's actions on PFAS, discuss local governments' and other stakeholders' responses to EPA's proposed rulemaking, discuss the implications of the rule itself, including recent research on the full costs of PFAS to local governments, and the path forward.
3:45pm – 5:00pm	Improving Recycling Access – Tools, Tips, Strategies, & Resources
	How can we ensure that all our residents have access to recycling in our communities? In this session experts with The Recycling Partnership (TRP) will share outreach and engagement strategies that can improve recycling access; offer insights into how your contracts influence recycling access and the types of materials accepted; and highlight new tools and resources developed by TRP to help your residents understand how to properly recycle – including TRP's new Recycling Program Solutions Hub, Recycle Check, and other grants, guides, and toolkits.

This presentation will provide data that cities can use to make the case for rate increases, as well as strategies to successfully seek approval. We'll also highlight case studies of challenges and solutions from several cities.

	Modern MRFs much less bemoan the woes of glass in single-stream recycling. With a rejuvenation in glass recycling clean-up and equitable MRF tipping fees, glass rejoins the ranks as a core recyclable. Cities and counties can design new processing contracts with greater transparency with glass processing and more recycled tons. While this formula may still have challenges in some areas of the US, a growing number of well- maintained MRF systems are being built or renovated with glass in mind. In this session, hear from MRFs, glass processors, and communities that have found success in glass recycling.

	In this session we will look at the current state of composting infrastructure and residential access to composting programs nationwide. Hennepin County will share their path from incentivizing and supporting organics programs to eventually requiring residential and commercial organics programs.
